LARGE GENERAL SERVICE ELECTRIC RATE RATES 107 Effective Date: May 10, 2019

APPLICATION:

To all service required by Customer on the premises, when supplied at one point of delivery and measured by one kilowatt-hour meter, when customer has entered into a contract for a minimum demand of 1000 kW.

Applicable to standby and supplementary service only in conjunction with the applicable rider for such service.

Not applicable to temporary, breakdown, resale, standby, or shared service.

CHARACTER OF SERVICE:

Three-phase, 60 cycles, at one standard nominal voltage required by Customer, as described in Utilities' Standards for Electrical Installations.

MONTHLY RATE:

MINIMUM BILL:

The monthly minimum charge shall be the customer charge plus the demand charge for the currently effective measured demand or such amount as may be required for line extension customers to justify the additional investment necessary to provide service and to cover the cost of rendering service.

ADJUSTMENTS:

The amount computed at the above Monthly Rate shall be adjusted plus or minus by an amount calculated in accordance with the formula specified in the Utilities' Power Cost Adjustment Clause which is incorporated by reference as a part of this rate schedule.

Second- Plus the applicable proportionate part of any directly allocable tax, impost or assessment imposed or levied by any government authority, which is assessed or levied against the Utilities or directly affects the Utilities' cost of operation and which the Utilities is legally obligated to pay on the basis of meters, customers, or rates of, or revenue from electric power and energy or service sold, or on the volume of the energy generated, transported, purchased for sale, or sold, or on any other basis where direct allocation is possible.

PRIMARY DELIVERY:

Customer may elect to take service at the primary voltage that is available, or in the Utilities' judgment, can be made available in the most practicable manner. When Customer contracts to take service at such primary voltage and provides all facilities necessary to take service at this voltage, the demand charge, before adjustments, will be reduced \$.247 per kW for nominal 13,800 volt delivery. Utilities may elect to measure such service on the secondary side of Customer's transformer installation.

CUSTOMER'S DEMAND:

The average kW supplied during the 15-minute period of Customer's greatest use during the current month, but not less than the higher of the following:

(1) 80% of the highest kW so established in the prior eleven months(2) 1,000 kW

If the power factor at point of measurement is found to be less than 85%, demand measurement may be made by kVA demand meter, in which case, one kVA as registered will be considered as .85 kW, but not less than the actual kW. If the instantaneous load exceeds the highest average 15-minute load by an unusual amount, such instantaneous load may be taken as the demand used for billing.

EXCESS KVAR:

\$1.59 PER kVAr by which the average kVAr supplied during the 15 minute period of greatest use during the current month in excess of 60% of Customer's Demand for the current month.

CREDIT:

If the current monthly load factor is in excess of 85%, a credit will be given in an amount of \$.0959 per percent of the excess load factor per kW of customer's demand.

PAYMENT:

Bills are due and payable each month upon presentation. If a bill is not paid within ten days from the date thereof, Utilities have the right to suspend service.

CONTRACT PERIOD:

Not less than one year, and for like periods thereafter, in accordance with Utilities' Agreement for Service.

TRANSFORMER CAPACITY:

If a customer requests transformer capacity in excess of 125% of previous 12 months maximum demand, a monthly charge of \$1.59 per excess capacity will be made.

RELOCATION OF FACILITIES:

If a customer elects not to provide all facilities necessary to take service at primary voltage as set forth under PRIMARY DELIVERY above, he will be billed the actual cost plus 15% overhead for relocation of facilities when relocations are made at the request of the customer.

RESERVATION:

The Greenwood Utilities Commission reserves the right to change this rate at any time it may deem necessary, and service is subject to compliance with Service Rules and Regulations and other Utilities' policies as are applicable.
