## MINIMUM MONTHLY CHARGE: Multiple Units

Where more than one building or dwelling unit is supplied through one meter the minimum monthly charge shall be increased $\$ 4.47$ for each unit in excess of one. A dwelling or business unit shall be considered a separate unit when its operation is separate and it has its own toilet facilities. If a dwelling unit and a commercial or industrial unit are served through one meter, the Commercial Water Rate will apply.

## SINGLE POINT DELIVERY:

The above rate is based upon supply of service to the customer's premises through a single delivery and metering point. Separate supply for the same customers at other points of consumption shall be separately metered and billed.

## ADJUSTMENTS:

Plus the applicable proportionate part of any directly allocable tax, impost, or assessment imposed or levied against the utilities or directly affects the utilities' cost of operation and which the Utilities is legally obligated to pay on the basis of meters, customers, or rates of, or revenue from water sold, or any other basis where direct allocation is possible.

## PAYMENT:

Bills are due and payable each month upon presentation. If a bill is not paid within ten days from the date thereof, the Utilities shall have the right to suspend service.

## RESERVATION:

The Utilities Commission reserves the right to change this rate at any time it may deem necessary, and service is subject to compliance with Service Rules and Regulations and other Utilities' policies as are applicable.
