Assists with the collection of water samples in a timely manner for monitoring water quality for our customers in accordance with the Mississippi State Department of Health, and other federal, state, and local agencies.

Performs all work tasks and projects safely and on time. Follows all instruction related to standard installation, repair, and maintenance practices. Provides support and duties for other operations departments as assigned. Reports all significant water quality and work task related problems to the Lead Water Operator as they occur. May involve on call availability for emergency response or water production related issues that may arise.
